

REGULATIONS OF THE PROMOTION "Upgrade your SLS capacity"

(hereinafter: "Promotion")

§1 General provisions

- 1. These Terms and Conditions (hereinafter: "Terms and Conditions") set forth the terms and conditions of the promotion for the purchase of a new SUZY 3D printer ("Promotional Product") from the offer of Sinterit Ltd. (hereinafter: "Sinterit"; "Manufacturer").
- 2. The promotion is directed exclusively to Sinterit customers who have already purchased one of the previous generation printers from the Manufacturer (or its distributor): Lisa, Lisa PRO or Lisa X model, and wish to purchase the SUZY 3D model of the printer covered by this promotion (hereinafter: "Participant").
- 3. The Promoter of the Promotion is a company under the name of **Sinterit Spółka z ograniczoną odpowiedzialnością** with its registered office in Kraków (30-741), 10 Nad Drwina Street, building B3, entered in the Register of Entrepreneurs by the District Court in Kraków, XI Commercial Department of the National Court Register under KRS number: 0000535095, NIP: 679-310-64-16 (hereinafter also referred to as the "**Organizer**").
- 4. The offer is only available on the dedicated website provided by the Organizer and promoted in the Sinterit Studio software.
- 5. The Terms and Conditions of the Promotion are available on the dedicated website of the Organizer.

§2 Terms and conditions of participation in the Promotion

- 1. The Promotion covers the first ten (10) orders of the Promotional Product placed by the Participant(s) under the terms and conditions set out by the Organiser iin these Rules.
- 2. Participant, in order to take advantage of the Promotion, is required to meet the following conditions together:
 - a) Have the status of owner of at least one Sinterit printer (Lisa, Lisa PRO or Lisa X;
 - b) provide the serial number of the Sinterit printer you own in order for the Organizer to verify your right to participate in the Promotion;
 - c) obtain confirmation from the Manufacturer of the Participant's ownership status to the Sinterit printer; In the event that the printer is found to have been sold to a third party, the Participant shall lose the right to take advantage of the Promotion;
 - d) pay at least 30% of the prepayment for the order no later than June 30, 2025.
- 3. If the prepayment is not made by the date indicated in point 2(e), the Participant loses the right to participate in the Promotion.

§3 Rules of the Promotion

- Under the Promotion, only the first ten (10) Participants who meet all conditions of participation, including the purchase of the Promotional Product, will receive a 10% discount on the standard net price of the SUZY 3D printer
- 2. The Promotion is valid from the date of announcement, i.e. April 4, 2025 until June 30, 2025 or until the pool of 10 Promotional Product is exhausted
- 3. The discount is calculated at the time of purchase after confirming that all conditions for participation in the Promotion have been met.
- 4. The discount cannot be combined with other promotions, discounts or discount codes offered by the Manufacturer.
- 5. Each Participant may purchase a maximum of one item of a Promotional Product under the Promotion.
- 6. The eligibility for the Promotion is determined by the order in which the order is placed along with the confirmed payment of the full prepayment amount. Only the first ten (10) orders meeting all specified conditions will be eligible for the Promotion.

§4 Processing of personal data

- 1. The administrator of the Participants' personal data is the Organizer.
- 2. Participants' personal data will be processed for: (a) to implement the Promotion and verify the fulfillment of its terms and conditions, and to execute the agreement or act before concluding the agreement at the Participant's request (Article 6.1.b and 6.1.f RODO/GDPR), (b) to fulfill the Organizer's legal obligations (Article 6.1.c RODO/GDPR), (c) to conduct marketing activities in case of voluntary consent and to handle the purchase process (Article 6.1.a RODO/GDPR).
- 3. Providing personal data is voluntary, but necessary to take advantage of the Promotion.
- 4. Personal data may be shared with entities supporting the Producer in the implementation of the Promotion (e.g. IT service providers, courier companies) on the basis of relevant entrustment agreements.
- 5. The participant has the right to access, rectify, delete, limit processing and object to processing.
- 6. All requests for personal data should be addressed to e-mail: dane@sinterit.com.
- 7. Detailed information regarding the processing of personal data is contained in the Producer's Privacy Policy.

§5 Final provisions

- 1. The Producer reserves the right to change the Terms and Conditions during the Promotion, but the changes must not violate the rights acquired by the Participants before the changes.
- 2. In matters not covered by these Regulations, the provisions of the Polish Civil Code and other applicable provisions of Polish law shall apply.
- 3. Any disputes related to the Promotion shall be resolved by a court having jurisdiction over the Producer's registered office in accordance with Polish law.
- 4. The organizer reserves the right to deny the discount for any reason.
- 5. The Terms and Conditions enter into force on [April 3, 2025] and are valid until June 30, 2025 or until the pool of 10 Promotional Product is exhausted.
